This NVIT guide will illustrate several common types of citations using the APA style format. It is strongly recommended that you consult with the *Publication Manual of the American Psychological Association, Sixth Edition (APA Publication Manual)* for complete information. Chapter 6, Section 6.11 - 6.21 and Chapter 7, Reference Examples are specifically helpful for guidance on parenthetical references and preparation of the reference list. The *APA Publication Manual* (BF76.7 P83 2010) is available in the NVIT library. Although the *APA Publication manual dictates that the Reference List* should be double-spaced, following examples are single-spaced to preserve space.

# **APA IN-TEXT**

# (PARENTHETICAL) CITATIONS

This NVIT guide will describe several common types of citations using the APA style format. It is compiled from the *Publication Manual of the American Psychological Association, Sixth Edition (APA Publication Manual)* as well as from online sources. Chapter 6, Section 6.11 - 6.21 is specifically helpful for guidance on parenthetical citations. Writers must acknowledge in their body of work the source of any quotations, opinions, interpretations, or specific facts that were the result of another person or group's research. The following is a compilation of basic citation styles.

### **Short Quotations or Paraphrases**

- Identify the source's author by surname (typically the last name) and the date of publication.
- Surnames and dates may appear either in the sentence or in parentheses.
- If including surnames in parentheses, always include the date of publication in the parentheses.
- · To cite a specific part of a source, indicate the page, chapter, figure, table, or equation
- Always provide page numbers for quotations. For online material without pagination, provide the number of the paragraph in which the quoted material appears.
- APA does not require page numbers for paraphrased material; however, including this information may be helpful.
- If the source has no author, use a shortened version of the title.

# **Work by One Author:**

Early onset results in a more persistent and severe course (Kessler, 2003).

### Paraphrase of one Work by One Author:

Meyers (2003) provided the definitive treatment of the issue....This study shows that no such correlation exists (Meyers, 2003, p.10).

#### Three to Five Authors:

Lynch, Laver, Hosea, and Joseph (2007) provided the definitive treatment of the issue....This study showed that no such correlation exists (Lynch et al., 2007).

### Source with No Author and No pagination:

According to College Bound Seniors (2008), "Total hours of preparation is the strongest predictor of SAT success" (para. 2).

### Citing an Indirect Source (Citing from a Secondary Source:

Kinsey's diary (as cited in Marx. 2003) is explicit: "I do not agree" (p.55).

### Citing an interview or personal communication:

J. C. Jones (personal communication, April 12, 2009) explained, "The Congress was ambivalent with regard to the Supreme Court's decision."
